1568 Agenda item 4 - Minutes of the Previous Full Council Meeting held 3 June 2025 for approval

1574 Agenda item 10 - Aldingbourne Community Sports Centre

It was noted that the CCTV was reviewed 24.06.25 between the Clerk and the Chair of the ACSC as the police had been notified by the ACSC of possible criminal activity. A crime incident number was provided but it was agreed that no further legal action would be taken on both instances although police had requested footage details, so they can speak to the parents involved with the children climbing on the roof as a safeguarding issue, and for the users of the hall to identify the children involved in the graffiti incident. The deposit for the user group involved would not be refunded and the users had agreed to this action.

Jonathan Leahy advised that they had been approached regarding the possibility of providing table tennis facilities for a new club. The ACSC are looking into these costings and may approach the parish council for a grant.

1575 Agenda item 11 - County, District Councillor's, & PCSO Reports:

West Sussex County Councillor Trevor Bence was not in attendance but had advised there was nothing new to report.

Arun District Councillor Anita Lawrence advised that there was a new Chair and Deputy Chair of the council now in place.

The PCSO had provided posters for the parish council to put up at the allotments advising that there would be more police patrols in the area, as there had been reports of cars gathering, and verbal abuse towards allotment holders.

- b) APC/ACSC Development Working Party notes of the meeting held 19.06.25 had been circulated with a recommendation that the request from the Shooting Club to install a bio disabled toilet should be agreed. All councillors approved this. Cllr Foott advised that she had spoken to Arun District Councillor Sue Wallsgrove regarding the funding that the parish council had for a MUGA from a S106 agreement made in 2013 and if this could be re-purposed for a different use. A meeting had been held with ADC Planning and Neil Crowther and David Easton had agreed that it could be used for a different project, but

a deed of variation would be needed. Cllr Foott will investigate what is required and how this can be progressed as it was discussed that it could be used to provide a path around the ACSC that could include gym equipment for the community to use.
