MINUTES of the Planning Meeting of the Aldingbourne Parish Council held on Tuesday 9 September 2025 at 7.00pm at Aldingbourne Community Sports Centre, Olivers Meadow, Westergate PO20 3YA.

1223 Agenda item 1 - Apologies for Absence

Cllr Sue Foott (Chair of the parish council and the planning committee) (personal).

As the Chair of Planning was not in attendance, Cllr Katherine Jarman was asked to volunteer to chair the meeting, proposed Cllr Flitter, seconded Cllr Brown.

1224 Agenda item 2 - Declarations of Interest

Nothing to declare.

1225 Agenda item 3 - Public Participation

Mike Link from the ABE CLT introduced himself and explained the role of the CLT in trying to provide social housing homes to local people. The Wings Wood development had been a real success with 34 homes being allocated via this scheme through Southern Housing Group. The CLT would like to continue collaborating with this model and are trying to engage with ADC and developers with little success as they ask housing associations to bid for this kind of housing provision. CLT have spoken to ADC and asked that they negotiate directly with the CLT and ask them for allocations on all developments to be provided to them rather than just housing associations. The CLT have approached all elected representatives to lobby on their behalf and may be looking to Aldingbourne and Barnham & Eastergate parish council for support.

Residents were in attendance regarding the Woodgate Centre development and their concerns on parking in Woodgate Road, as they have been advised that work will be starting on the site in January 2026 which will then have heavy lorries and machinery adding to the problem that already exists. They were surprised that following a change in developer that a new application had not been submitted. The Clerk advised that the development already had approval by ADC and that the parish council had submitted a robust objection letter via their planning consultants at the time, as the land already comes with planning permission a new

developer does not need to re-apply but will need to comply with any conditions that were imposed by ADC which are outlined in the Officers report, it was also stated that the development was always going to be accessed from Woodgate Road and Cllr Flitter reiterated that as WSCC Highways would have been consulted, once approval is given then there is nothing that can be done on the access point. Mention was made of the A29 re-alignment but there is no timescale for this and access to the development from the re-alignment was not thought to be part of the original approval. Cllr Jarman agreed to research and provide wording for a letter to be sent to ADC on their concerns. Agreed by all councillors.
