# Minutes of the meeting of Aldingbourne Parish Council, held on 3<sup>rd</sup> April 2018 at the Aldingbourne Community Sports Centre

Present: Councillors; Foott, Turner, Blaylock, Warden, Harbord and Sturgess.

Apologies: Cllr Beaton, Turner. Cllr Foott was elected Chair in their absence.

**Declarations of interest-** Councillor Blaylock made a declarations of personal interest in respect of Allotment matters. Cllr Foott and Blaylock made personal declarations in respect of the item regarding the Planning application AL/123/17/PL Mildmay Hook Lane.

## **Urgent Items None**

- **407 Public Session** A question was raised regarding the possibility of a Lidsey by pass as a result of the proposed strategic housing allocation in the draft Local Plan. Cllr Whittington explained that this would be required if the site to the south was agreed by the Inspector.
- **408.** Confirmation of Minutes of meeting held on 6<sup>th</sup> March 2018 On a proposal by Cllr Warden and seconded by Cllr Sturgess the minutes were approved and signed by the Chairman.
- **409. District/County Councillors Report** Cllr Hughes indicated that the Local Plan could be approved by September 2018. He added that the BEW Cluster group had met and Cala Homes advised of the S106 requirements. Cllr Whittington advised that Eastergate and Barnham were holding a joint annual parish meeting. He also updated the Council on the strategic cycle route and the completed section at Slindon.
- 410.Annual Parish Assembly Agreed that this would be held before the Annual meeting on 1st may 2018 and that speakers would be invited from the Aldingbourne Trust and the ACSC. Meeting to start with refreshments at 6.30pm followed by presentations with the Councils Annual meeting to follow.
- 411. Planning Applications- Noted that AL/20/18 Bridge Cottage Lidsey and AL/15/17 Cala Homes site, Land west of Westergate Street had been referred to the Council by the Planning Committee. The Clerk was asked to obtain an extension of time so the Council could take advice regarding the validity of the Neighbourhood Plan policies. Cllr Foott informed the meeting that the ANDP would now not being given weight in relation to housing numbers as it was deemed out of date. It was agreed by the Council that further legal advice was needed regarding all the policies in the NP.

The Council also considered Arun's recent decision regarding AL/123/17 - Mildmay Hook Lane and the apparent lack of regard for policy H1 of the NP and the lack of support from District Cllr Charles regarding the Parish objections.

- 412. **Community Land Trust Steering Group** Noted the next meeting would be on 16<sup>th</sup> April 2018 and that a representative from Aruns Housing Needs Department would attend. -
- **413.Proposed Community Land Trust** Noted that a successful open meeting had been held on 20<sup>th</sup> February with over 75 attending. Agreed to form a Steering Group to guide the process to a full Trust, the first meeting to be held on 12<sup>th</sup> March 2018.
- **414. Play Area** Noted that repairs were required and agreed Cllr Turner should contact Mr Kennedy as a matter of urgency to assess repairs required.
- 415. **ACSC Trustee-** On a proposal by Cllr Sturgess and seconded by Cllr Harbord it was agreed that Cllr Warden would be the Parish Councils Trustee, replacing Cllr Chown.
- 416. Business Plan 2018 Members noted the update.
