Also the turning behind the Basmati restaurant on so many occasions now I find lorries trying to turn into Niton Road towards Barnum I'm having to sometimes go out and tell the drivers they cannot turn as this road is very narrow is it about time that there was a no turning right sign put in place to stop this happening . thank you"
